StarPortal

Online Review, Admissions & Nominations Portal





StarPortal is a web portal that allows recipients of a Notice of Intended Prosecution (NIP) to view their evidence online. Optionally, they can submit an online admission or nominate the driver of a vehicle instead of returning the S172 paper form.

StarPortal can be deployed as either a stand-alone product, interfacing with PentiP, or as part of StarTrag's DOME back-office solution.

# Reduce manual processes for admissions and nominations

#### **Online Admissions**

Drivers can make admissions online using StarPortal's step-by-step process. Identification will be confirmed by asking the driver to enter their driving licence details. This process is much less time consuming than completing a paper form for both the general public and ticket office staff. Admission information is sent directly to the back office to continue the enforcement process.

#### **Online Nominations**

Members of the public can nominate another driver using StarPortal's online nomination functionality. Nomination information is processed and sent to StarTraq's DOME back office. A new Notice of Intended Prosecution can then be sent out to the nominated driver. Online nominations can also be made by hire companies, drivers who weren't the registered keeper at the time of the incident or if the vehicle has been sold recently.



StarPortal gives the public an easy way to access and review their traffic offence evidence\*. An offender can nominate another driver or make an admission via the portal, view related photographic evidence, inspect any related documents and see links to road safety support sites.



#### **Online Evidence Review**

Drivers can access all supporting evidence associated with their offence. This includes any images captured from the traffic enforcement camera, copies of notices and other supporting documents such as camera calibration certificates. StarTraq DOME also allows certain images to be locked from online review.






### Reporting

StarPortal features a powerful reporting platform that is accessible via the StarTraq DOME. Full usage statistics are available to create reports, including the number of logins, the number of nominations and/or admissions received online and the breakdown of the type of device and browser that are being used to access the portal.

## Compatible with mobile devices

StarPortal is a browser-based application, this means that it will work on any computer or smart device with an inbuilt web browser.



How StarPortal works with PentiP.

StarPortal accesses the passcode, generated by PentiP, which allows the current alleged offender to log in to the system. Once a nomination or admission has been received, StarPortal will create a Notice of Intended Prosecution (NIP) response file that can be imported back into PentiP.
